GENERAL TERMS AND CONDITIONS FOR BICYCLE HIRE

Article 1 - Subject of the contract: the hire of a cycle with its basic equipment by LA FORET TOTEM, hereinafter referred to as "the hirer".

Article 2 - Cycle equipment : all rented cycles have basic equipment consisting of the following accessories: Electric assistance system (motor, battery and console) for EABs only, anti-theft device and helmet..

Article 3 – Commencement, availability and recovery :

This contract is only valid for the duration of the hire period. If the hirer keeps the equipment beyond this period without having regularised his situation, he loses the benefit of all the guarantees provided for in the contract. The hirer acknowledges having received the rented bike in good working order with the basic equipment. He/she declares that he/she has personally had full latitude to check the equipment and choose it in accordance with his/her needs and level of riding..

Article 4 – Payment and methods of payment for the service: 30% of the cost of the service is paid by the hirer at the time of booking on the booking platform. The remaining 70% will be deducted at the time of collection of the equipment covered by this contract, via the credit card used to make the reservation. The other method of payment accepted is cash..

Article 5 – Use : The hirer certifies that he/she is fit to use the rented equipment and undertakes to use it himself/herself. By express agreement between the parties, it is strictly forbidden to lend or sublet the equipment to a third party.

The hirer undertakes to use the rented bicycle(s) with care and without danger to third parties, in accordance with the regulations in force. We strongly recommend that adult hirers wear helmets, and it is compulsory for all children under the age of 12. When parking equipment, it is compulsory for the hirer to place the anti-theft device on the bicycle(s). In the event of theft of the equipment, the hirer must inform the hire company without delay, lodge a complaint with the appropriate authorities, provide a photocopy of the complaint and inform their own insurance company. The deposit will be cashed.

Article 6 – Liability for breakage - theft - insurance

The hirer is not covered for any damage to the rented item and is personally liable for said damage, breakage and theft. Insurance is the responsibility of the hirer. By signing the hire contract, the hirer confirms that he/she has adequately covered the risks associated with the use of the equipment hired.

The equipment is not insured by the hirer against theft or breakage

under this contract. It is therefore the responsibility of the hirer to cover the risks in the event of damage to the equipment.

In the event of breakage, the hirer undertakes to return the damaged equipment, which must be identifiable and complete. Damage to the equipment will be invoiced to the hirer at the current rate by an authorised professional (the Cyckes CHEDAEUX workshop in Caudan). Theft and loss of equipment are not covered. In these cases, the equipment will be invoiced to the hirer on the basis of its value, less a percentage for obsolescence of 20% per year. In the event of theft by the hirer, misappropriation or damage of any kind resulting from non-compliance with the rules of use or regulations in force, or with the terms and conditions of this contract, the hirer is entitled to take recourse for the totality of the loss.

Article 7 – When booking online, the bank imprint will also be kept (along with the payment of 30% of the hire charge) as a deposit. **This deposit of €500 per bike EAB (€300 per mountain bike)**, which will not be cashed in, will be valid for the entire hire period. On return of the equipment, the deposit will be released if no damage or theft has been recorded. Otherwise, the damage referred to in article 6 will be invoiced as explained in the article of this contract and will be debited from the credit card used at the time of booking.

Article 8 – Return: the rented equipment must be returned at the time stipulated in the contract. For safety reasons, the hirer undertakes to inform the hire company of any damage to the helmets.

Article 9 – Eviction of the lessor : the accessories delivered with the equipment must not be removed or modified by the lessee. The equipment may not be transferred or given as security. In general, the lessee undertakes not to grant any right, real or otherwise, in respect of the leased item to anyone that may affect its use or limit its availability or the full ownership of the hirer.

Article 10 – Jurisdiction : in the event of any dispute relating to this contract, the competent court will be that of the registered office of the lessor's company, to which the parties assign exclusive jurisdiction.
